## Educators Eligible for Tenure Pending Board of Education Approval Fall 2021

Educators are eligible for tenure in Tennessee when they have completed a probationary period of 5 years (45 months) within a seven year period and have received a TEAM evaluation composite score (overall Level of Effectiveness score) of 4 (above expectations) or 5 (significantly above expectations) for the last two years of the probationary period as a non-tenured teacher (Tennessee Code Annotated 49-5-503).

As well, educators are eligible for tenure re-instatement when they have served a two-year probationary term after moving from tenured status to probationary status.

We are pleased to present the following educators who meet eligibility requirements to receive tenure in Metro Nashville Public Schools. Educators are listed with their teaching license number. We commend them for their outstanding performance in the classroom and commitment to our district.

No new tenure is awarded on this date.

#### **Re-Instatement of Permanent Tenure**

Tenured educators with a break in service having left and since returned to the district must serve a two-year probation period of service upon their return in order to again be eligible for tenure. Educators below meet the criteria to have permanent tenure re-instated because their tenure was awarded before July 1, 2011.

#### **Office of Talent Management**

#### Information about earning tenure:

- Teacher Tenure is an employment status granted under TCA 49-5-501 and TCA 49-5-504(a). This
  status applies to "teachers" (which can include teachers, supervisors, principals, directors of
  school, and all other certificated personnel employed by a local board of education).
- Currently, the law requires five years of service and minimum overall level of effectiveness scores (from state approved TEAM evaluation model) of 4 or 5 from the most recent two years.
- Tenured educators with a break in service, having left and since returned to the district, must serve a two-year probationary period in order to again be eligible for tenure.
- Meeting the criteria is not enough, tenure is only awarded to educators by approval of the MNPS Board of Education.
- Between 200-300 teachers in MNPS are awarded tenure each year.

#### Impacts of Tenure Reform:

- Tenure is more difficult to earn since tenure reform laws were passed in 2011.
- Previous to 2011, teachers earned tenure after three years of service and re-employment in the following year. There were no state mandated performance requirements prior to 2011.
- Consistent with the goals of the reforms, the number of teachers who are receiving tenure has decreased while teacher effectiveness among newly tenured teachers was higher. As well, the diversity of the tenured sector of the teacher workforce has remained stable.
- Around 6,000 Tennessee teachers were eligible for tenure in TN in 2009-10. Around 1600 Tennessee teachers were eligible for tenure in TN in 2014-15.

- Schools that are safe and free of violence, weapons, and drugs are necessary to ensure the well-being of all children and the quality of their education.



## **Teamwork**

#### **MNPS Security**

• Works with schools to establish safety and security plan, respond to incidents, run drug and weapon searches

#### **MNPD SROs**

 Support schools by building positive relationships with students and serving as a direct point-of-contact with law enforcement when needs arise

#### **Student Support Services**

• Supports school leadership to develop programs, policies, and protocols to reduce behavioral incidents and create safer environments through strategies to address conflict before it escalates or turns to violence

#### School staff

• Each team member in a school has a responsibility to help keep the students and staff safe by addressing problems before they start and quickly resolving conflicts when they do happen.



## **MNPS Security Safety Collaboration**

- MNPS Security and MNPD collaborate with school administration for annual physical security assessment.
- Collaborate with school leaders in the development and adoption annually of comprehensive school emergency operations plans
- Coordinate and provide training in the areas of emergency management, CPR/AED, entry point metal detection, RAD Kids/Women, Crisis Prevention Institute (CPI), and parent reunification.
- Special event contingency planning of athletics, graduations, proms, and other school functions.
- Secure or manage grant funding for security equipment, signage, physical safety enhancements, planning, etc.



# Advocacy Centers MNPS Elementary Schools






### **Advocacy Centers**

The Advocacy Center is a regulation space designed to support social-emotional health and wellness for elementary students who become dysregulated during the school day and need short-term trauma-informed and restorative practices provided on the spot when needed.

# What Happens in the Advocacy Center?

# Advocacy Center Services will include 4 types of support provided by an Advocacy Center Coach:

- Mindfulness-based Regulation Strategy from a menu of calming practices (e.g., guided breathing, movement, yoga, fidget tools or other grounding activities)
- Connection and Reflection with a caring adult
- Accountability Action to restore or repair harm (only when needed)
- Re-entry Support for successful re-integration back to the regular classroom







# Navigator Sown To Grow





# Navigator 2021-22

- Every student matched with a Navigator. Navigator-Student match stays consistent during student's tenure at school if feasible so the relationship can grow over time.
- Weekly 5-minute check-ins during school hours documented using Sown to Grow platform.
- Teachers **respond to student Sown to Grow check-ins** and flag the Navigator or other school personnel if immediate follow-up is needed.
- Lead Navigator and Navigator leadership team monitor school-level Sown to Grow dashboard and address flagged responses.
- Navigator conducts in-person or virtual/phone one-on-one check-ins at least **once per month** (more if needed).
- Navigator is included in **Multi-Tiered Systems of Support meetings** where appropriate.




# Youth Court Middle and High School

### **Youth Court Opportunities**

Youth Court is a means through which students can transform their schools

- Students help students make better decisions
- Students learn about the role of the law in society
- Students acquire improved literacy and critical thinking skills
- Students improve conflict resolution skills.
- Youth gain a better understanding of their rights, justice system and the law, and are empowered to make better decisions in their daily lives.
- Youth learn that a bad decision does not necessarily mean that the person who made the mistake is bad.
